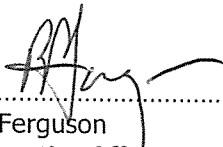
- 1 This notice may be cited as *Whitsunday Regional Council (Making of Local Laws) Website Notice (No. 1) 2022*.

Making of local laws

- 2 Whitsunday Regional Council (the "Council") has, by resolution dated 12 October 2022, made the following local laws and subordinate local laws:
- (a) *Local Law (Amending) Whitsunday Regional Council Local Law No. 1 (Administration) 2022*; and
 - (b) *Subordinate Local Law (Amending) Whitsunday Regional Council Subordinate Local Law No. 1 (Administration) 2022*,
- (collectively, the **Local Laws**).
- 3 In accordance with section 29B(4) of the *Local Government Act 2009*, the Annexure to this notice sets out the relevant details of the Local Laws.
