Financial Support for a Junior Elite Athlete Grant Guidelines

Financial Support for a Junior Elite Athlete is available for young athletes who are participating in a representative competition at regional, state or national level. The grant is provided by Council to assist in meeting the costs associated with participating in a representative sports program.

To be eligible, an athlete must meet the following criteria:

- Be 18 years or younger at the time of competition.
- Does not have outstanding debt to Council.
- Be amateur in status.
- Must not be receiving funding from any other sources.
- Be a permanent resident of the Whitsunday Regional Council local government area for at least 12 months prior to application.
- Be selected to represent North Queensland, Queensland or Australia (or equivalent as assessed by Council's nominated Officer) in an officially recognised State, National or International event. Applications where an athlete has nominated themselves or chosen to participate in the sports program or event will not be eligible. Athletes must be selected through trial games or matches or meet qualifying times to attend competition.
- Applicants who have successfully received funding under this program, and are chosen to represent at a higher level, may be eligible for further funding, but this will be at the discretion of Council.
- Funding is not provided for applicant(s) representing religious organisations or government departments.
- Must provide written verification of selection or qualification from the relevant organisation.
- Must provide evidence of associated costs to participate in the competition.
- Must provide a signed Statutory Declaration confirming applicant's financial contribution and residency within the Whitsundays for at least 12 months prior to application.
- Applications MUST be received prior to the competition. Applications for competitions that have already occurred will NOT be considered.

Applications must be:

- Made on the approved application form to Council; and
- Accompanied by any documents required under the application form to be attached to, or given with, the application including written verification of selection from the relevant organisation, evidence of

Funding Overview:

- Approved applicants will receive \$250.
- Applicants who have successfully received funding under this program, and are chosen to represent at a higher level, may be eligible for further funding, but this will be at the discretion of Council.
- Funding is to be capped at one (1) application per Organisation/Junior Elite Athlete, including Community Donations and Community Sponsorship per financial year.
