PURPOSE

For Council to consider authorising the CEO to provide a letter of support on behalf of Council to the Bowen Pipeline Company for its Bowen Pipeline Project based on representations made by Sean Brown at the Briefing Session on 21 September 2022. The letter of support would allow the Bowen Pipeline Company to further progress their project as a Coordinated Project through the Office of the Coordinator General.

OFFICER'S RECOMMENDATION

That Council authorise the CEO to provide a letter of support on behalf of Council to the Bowen Pipeline Company for the Bowen Pipeline Project, noting the intentions of the letter of support are as follows:

- It will assist the Bowen Pipeline Company in its efforts to have the project further progressed by the Office of the Coordinator General as a Coordinated Project in which Council would become a referral entity.
- 2) It forms a non-binding agreement to show Council's support in good faith for the overall project concept which would see the supply of secure water for private industry and agriculture in the Bowen area, leading to positive economic impacts.

BACKGROUND

Sean Brown from the Bowen Pipeline Company presented to Council at the Briefing Session held at Bowen Council Chambers on Wednesday 26 September 2022. At this meeting Mr. Brown requested a more recent letter of support from Council for the Bowen Pipeline Project noting a previous letter of support had been sent in December 2019. Mr. Brown also outlined the project at a high level, mentioning the construction of the 100km pipeline from Burdekin to Bowen would see economic benefits to the region through the supply of a secure water source for Bowen agriculture and private industry.

There has not been a previous resolution of Council to support the project.

DISCUSSION/CURRENT ISSUE

Council officers have been liaising with the Bowen Pipeline Company since 2017. Previous terms of Council have shown support for the project based on the concepts provided by Sean Brown. Council officers have shown some concern for the conceptual alignments of such a large diameter pipeline through Council managed road reserves however this detail or any future concerns would be referred onto the Office of Coordinator General if the project is approved as a Coordinated Project. The pipeline alignments shown as concept do not have any bearing at this stage on the non-binding letter of support requested by Sean Brown of the Bowen Pipeline Company at the recent Briefing Session of Council.
