## 12.1 - Budget Review 3

MEETING DETAILS: Ordinary Council Meeting - Wednesday 28 May 2025

### **PURPOSE**

To review the current budget and make amendments to better reflect the current and forecast financial position of Council and to confirm priorities for capital projects to be finalised in the 2024/25 financial year.

### **EXECUTIVE SUMMARY**

The Budget Review 3 (BR3) presents an increase in the operating deficit forecast for the 2024/25 financial year to \$3.6M. This has been influenced by budget risks forecast for the year through a variety of movements relating to revenue and expenditure.

This deficit position is anticipated to be a one-off event as Council manages growth projects and absorbs one-off budget risks during the current financial year. Council is expected to maintain a sound financial position from 2025/26 onwards in line with historical performance achieved outside of 2024/25 financial year.

### OFFICER'S RECOMMENDATION

That Council resolve:

- A. In accordance with section 170(3) of the *Local Government Regulation 2012*, to revise the Whitsunday Regional Council Budget adopted for the financial year 2024/25, as presented in the following statements prepared in accordance with section 169 of the Local Government Regulation 2012:
  - 1. Revised Statement of Comprehensive Income,
  - 2. Revised Statement of Financial Position,
  - 3. Revised Statement of Cash Flows,
  - 4. Revised Statement of Changes in Equity for the financial year 2024/25,
  - 5. The resulting Revised Long-Term Financial Forecast for the financial years 2024/25 through 2033/34, inclusive,
  - 6. The Revised Measures of Financial Sustainability; and
- B. To make the following transfers to and from reserves for the financial year 2024/25:
  - 1. \$942,527 from the Infrastructure Reserve to fund capital works projects, and
  - 2. A net transfer of \$13,172,611 from the Capital Works Reserve, as follows:
    - a) \$6,448,656 to the Capital Works Reserve, and
    - b) \$19,621,267 from the Capital Works Reserve to fund capital works projects.
  - 3. A net transfer of \$100,000 to the Disaster Resilience reserve, as follows:
    - a) \$300,000 to the Disaster Resilience Reserve, and
    - b) \$200,000 from the Disaster Resilience Reserve to fund roads betterment works.

4. To the transfer of \$1,320,000 from Operational Reserves to fund long term capital planning projects.

#### BACKGROUND

Council reviews quarterly, its adopted budget to make appropriate adjustments for changes and to promote transparent financial management. It is a legislated requirement for an amended budget to include all items identified in section 169 of the Local Government Regulation 2012.

Council has reviewed its financial performance up to 31<sup>st</sup> March 2025, both operational and capital, and identified several revisions, both positive and negative, which have been incorporated into the revised budgeted financial statements for 2024/25.

The original budget for the financial year 2024/25 was adopted by Council on 26 June 2024 and the first Budget Review was adopted on the 30<sup>th</sup> October 2024 and the second Budget Review adopted on the 26<sup>th</sup> March 2025.

### **DISCUSSION/CURRENT ISSUE**

Overall, the budget review reports an operating deficit \$3,662,508 forecast for the 2024/25 financial year.

## **BR3 REVISED BUDGET SUMMARY**

Financial Year: 2024/25

Period ending: 31 March 2025



#### **BACKGROUND**

Throughout the year, Council reviews its adopted budget to make appropriate adjustments for changes and to promote transparent financial management. It is a legislated requirement for an amended budget to include all items identified in section 169 of the Local Government Regulation 2012.

Council has reviewed its financial performance up to 31<sup>st</sup> March 2025, both operational and capital, and identified several revisions, both positive and negative, which have been incorporated into the revised budgeted financial statements for 2024/25.

The original budget for the financial year 2024/25 was adopted by Council on 26 June 2024. Budget Review 1 was adopted by Council on 30 October 2024, and Budget Review 2 was adopted by Council on 26<sup>th</sup> March 2025.

This report addresses:

• Budget Review 3 tabled for adoption by Council on the 28 May 2025.

#### **DISCUSSION/CURRENT ISSUE**

The revised budget was facilitated through targeted discussions with Departments across Council to understand operational and capital budget impacts and deliverability across the organisation.

### Operational Budget

The operating budget changes are summarised below with Table 1 with details on changes in Financial Statements provided in Attachment 2 – Revised Budgeted Financial Statements.

Operating revenues and expenses are proposed to be amended as follows:

Note: A negative figure (in red) in the "Net Change" column indicates a decrease in revenues or an increase in expenses.

The operating net result of the changes in revenue and expenses is a revised budgeted deficit of \$3,662,508 for the financial year 2024/25, an increase of \$1.89M from the Revised Budget (BR2) adopted on 26 March 2025. Included in this movement is \$1.33M decrease in revenue and net \$564K increase in expenses that relate to budget risks that have been mitigated during the Budget Review 3.

As detailed in Table 2, proposed revenue revisions total a decrease of \$1.33M. The primary contributors to the net decrease in budgeted revenues include:

- Decrease in Sales of Goods & Services \$998K Passenger Fees at the Airport were reduced from \$6M to \$5M offset where possible by reductions in expenditure. A new contract for additional flights was expected to be finalised in the current financial year but timing did not align with budget expectations. Revenue has been reduced to align with anticipated flight numbers for the year.
- Overall increase in Operational Grants & Subsidies of \$73K with movements across IT, NRM, & Open Spaces to align with revenue recognition expectations. The corresponding materials & services expenditure has also been adjusted to reflect the changes in engagement of consultants & contractors.
- Decrease in Other Income by \$405K Reduction in Airport's Passenger Screening Fee Income, as per the decrease in Passenger Fees, due to the timing of contract negotiations offset where possible by reductions in expenditure.

Additional details of the proposed revisions to Expenses are contained in Table 3:

- Materials and services have increased by \$628K which has been affected largely by increased costs for the Network and Master Plans (\$1.32M) to be funded from the Operational Initiatives Reserve based on expected spend during this financial year, and timing of the AMI project (\$278K). These increases were partially offset by an overall reduction in Airport's Materials & Services of \$938K, alongside the revenue reductions.
- Overall, employee costs reduced by \$65K after vacancy adjustments to March were applied.

Figure 1: Summary Revisions

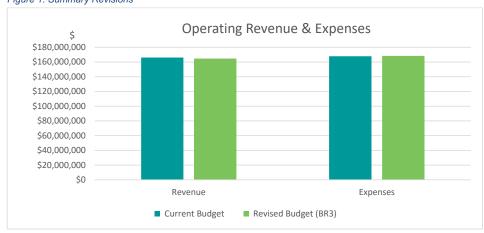


Figure 2: Revenue Revisions

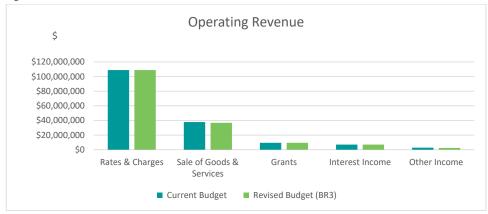
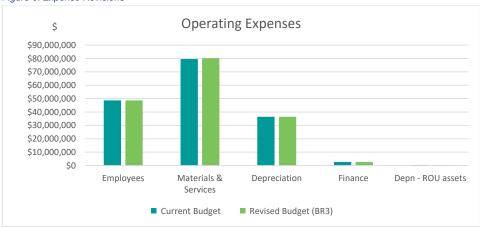


Figure 3: Expense Revisions

This demonstrates a movement from a deficit of \$1.77M to a deficit of \$3.66M. The revised budgeted financial statements for 2024/25 and as well as the nine years to 2033/34 are shown in Attachment 2. The main movements identified at a directorate level include the vacancy adjustment through Office of the Mayor and CEO and the Master Planning and Network Planning budget added.

### Capital Budget

A detailed review and project health check by project managers has been undertaken across all capital projects. The proposed amendments to the capital budget are based on the capacity to deliver considering both supply chain issues and project milestones.

In total, the capital works and remediation program has decreased from \$91.7M to \$91.2M, with a net decrease of \$549K. Rephasing of projects has been between years and totals a decrease of \$2M of projects to be delivered in outer years.

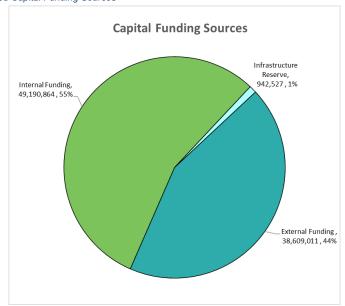

### Long Term Financial Forecast (LTFF)

The long-term forecast has been reviewed with assumptions made in the forward years based on current operations and economic conditions. The forward year forecasts are presented in Attachment 1.

The ratios forecast in the LTFF indicate an improved position in the longer term, following some immediate pressures to address short term impacts in the operational budget.

The financial ratios over the ten year financial forecast period are variabel and generally within the accepted ranges that signify a sound basis for the long term financial health of the organisation, and are shown in Attachment 4. Council is continuing to focus on increasing its asset management maturity, development of Asset Management Plans, Network Planning, and continued implementation of Asset Management as a priority.

#### FINANCIAL IMPLICATIONS

The current ratios are based on underlying assumptions for growth and revenue which have been estimated on a conservative basis, and these are forecast where possible to mitigate the risks identified from unforeseen shocks that could impact the short term and long-term multi-year impacts. Financial risks continue to be addressed on current projections, and these will be managed at the operational level by each Directorate.

The proposed budget review provides the current year sustainability ratios and are detailed in Table 7. Even though some ratios have trended slightly upwards from the Original Budget, all ratios are well within recommended ranges, indicating a long term stable financial position.
